League Rules

- All games are scheduled for Thursday Evenings between 6 and 11 pm. Games will consist of two 25 minutes halves with a five minute intermission.
- Teams will receive 5 points for a victory, 3 points for a tie, 1 point for each goal scored (up to a maximum of 10 goals), and 5point for a shutout, for **a maximum of 20 points in a single game**. There are no overtime periods. At the conclusion of each game the team captain or one designated representative must notify the league commissioner or his designated appointee of the game result **and the score**.
- The top four teams in points at the conclusion of Week 7 will participate in a two game playoff. In the event of a tie in point totals, the following will be used to break the tie: head to head records; goals scored by each team; goals against each team; number of shutout victories.
- Participants may register as individuals or teams. The cost for individuals (\$65) or teams (\$525) is required before the start of play. There is an additional cost for team's needing shirts. No team or individual will be able to participate without paying this fee. (Checks made payable to: *The 7 v 7 Soccer League of Ewing*).
- Each team must submit a roster at the start of the season. **NO player is permitted to play unless listed on the team roster and having signed both the League and Township Hold Harmless Insurance Waivers**. All players must show proof of individual medical insurance to play. Failure to comply will result in the forfeiture of all games involving the offending player(s). Players may be added to the roster anytime during the season, but must compete in at least one game to be eligible for playoffs/championships.
- Teams have the option of wearing shirts provided by the League (each team will be provided with 10 team shirts) or wearing uniforms acquired elsewhere. Whether provided by the League or not, it is required for all teams to have complete matching jerseys. Players must be properly uniformed with team shirts, shin guards and shoes to play. No jewelry may be worn on the field of play.
- All teams will be required to select a team coach/captain and an alternate. These individuals will be responsible to enforce the compliance of all league rules, submit rosters, pay league fees, etc.

Game Rules

- All FIFA rules apply, with the exception of:
 - Each team will field a team of four players and 1 goalkeeper (clearly delineated with a distinct and different jersey).

- Goalkeepers are not permitted to punt or drop kick the ball. The goalkeeper may distribute the ball with his hands only.
 - The field of play will follow the gymnasium basketball court markings. Play off of the walls is permitted on side A and the walls behind each goal (play caught in the back of the net(s) will be stopped and restarted with a re-kick at the referee's discretion). Play on side B (bleacher side) will be dictated by the basketball sideline at the referee's discretion.
 - Size of the goals are reduced from standard size to 6' by 12'.
 - Slide tackling is **not** permitted. Players must remain on their feet in challenging for a ball, (subject to a referee's discretion).
 - Substitutions can be made on the fly, but a player must be clearly off of the field of play and not involved in the play before a substitution is permitted to enter.
 - Off-sides penalty is not enforced.
 - Any player penalized with a red card (or two yellow cards in a single game) will be dismissed from the current game and the next two subsequent games. Severe situations may warrant the removal from the league. Such situations will be decided at the sole discretion of the League Commissioner.
- The League will provide a Futsal ball for all games.
